The licence noted above is subject to the following condition(s):

- 1. This Temporary Licence (#2640-T01) is issued for the continued operation of 107 beds at the Home after the previous Long-Term Care Home Licence (#2640-L01) for these beds expired on January 16, 2021. The Temporary licence (#2640-T01) is amended effective January 1, 2023, to extend the term of the temporary licence from December 31, 2022 to June 30, 2025.**
- 2. Pursuant to section 114(2)[1] of the *Fixing Long-Term Care Act, 2021*, the Director may revoke this Temporary Licence before the end of its term upon giving at least 6 months notice of the revocation to the Licensee.**
- 3. Where the Director makes a revocation order in accordance with condition #2 above, and the revocation will result in the closure of the Home, the order will indicate the dates by which the Licensee is required to give a closure plan to the Director under s. 361(3) of Ontario Regulation 246/22 (the Regulation) and to enter into a closure agreement with the Director under s. 361(6) of the Regulation.**
- 4. Where the Director makes a revocation order in accordance with condition #2 above, and the revocation will result in the closure of the Home, or beds in the Home, then at least 16 weeks before the Home/beds are to be closed the Licensee shall provide a written notice to every resident of the Home/beds, that are to be closed, or to his or her substitute decision-maker, if any, and to any other persons either of them may direct, to the placement coordinator for the geographic area in which the Home is located, and to the Director.**
